# **Transport Sector Romania**

(Last update of the information: December 2014)

#### Mandatory declarations on posting

Mandatory declaration 5 days before posting workers start working in Romania. Not special provisions for transport sector.

Legal base: G.D. no. 104/2007 to regulate specific procedure concerning the posting of employees in the transnational provision of services in Romania.

## Compulsory documents (distinguishing for road transport sector of goods and of people

-copy of the transport license for every vehicle

-identity card of the driver

-driving license

-professional certificate

-certificate of registration for company

-vehicle insurance

-international transport permit

#### <u>Minimum wages</u>

It is a mandatory minimum wage by Law no. 53/2003 – Labour code. The level of the minimum wage is set through government decision. Since 1st of July 2014 the minimum wage is 900 RON (about 205 EUR).

- No sectorial collective agreement in transport.

#### Wage supplements

Salary bonuses related to working time are mandatory by Law no. 53/2003 – Labour code:

- min. 75% for overtime;
- min. 25% for night work;
- negotiable percentage for weekends;
- min. 100% for national holidays.

No sectorial collective agreement in transport.

## Maximum working time and minimum rest

#### Driving time: Regulation 561/2006/CE

Working time:

Government Decision no. 38/2008 on the organization of working time of persons performing mobile road transport activities transposing EU directive 2002/15/EC

- maximum working time: daily - exceptionally 12 hours only followed by minimum 24 hours of rest; weekly - 48 hours.

- minimum rest: daily - 12 hours, exceptionally 8 hours on shift change; weekly - two consecutive days usually Saturday and Sunday.

No sectorial collective agreement in transport.

#### Minimum paid annual holiday

- 20 working day.
